Martha Hill Jamison of Houston is retired, and previously served on the Fourteenth Court of Appeals, and a judge of the 164th Civil District Court for 9 years. She is board certified in Civil Trial Law by TBLS. Additionally, she is a member of the State Bar of Texas and the American Law Institute and former president of the American Judicature Society. Jamison received a Bachelor of Arts in journalism from The University of Texas at Austin and a Juris Doctor degree from The University of Texas School of Law. Martha Hill has been appointed by Governor Abbott to Texas Commission on Judicial Selection.



Lee Parsley is General Counsel for Texans for Lawsuit Reform (TLR). He has worked with TLR since 2002, drafting their legislative proposals, testifying in committees, and working for passage of TLR’s agenda with members of the Legislature. Parsley obtained an undergraduate degree and an MBA from Texas Tech University before graduating from Texas Tech University School of Law in 1989. He has practiced law in Austin since graduating from law school.
